# HOUSING OPTIONS

Temporary Housing – When you first arrive in Ontario, you may need a temporary place to stay. Hostels are low-cost alternatives to hotels. To find temporary housing, search tourism websites in your area or buy a tourist guidebook that lists accommodation options.

Non-profit Housing Co-op – Co-ops are owned and managed by members or residents, but residents do not own their units. You must apply to live in a co-op and rents are usually lower than average. For more information, visit onpha.on.ca or findlink.at/NPHousing

Government-assisted or Subsidized Housing – In subsidized housing, rent is based on your income. Many people spend years on the waiting lists for this type of housing. For more information, visit ontario.ca or findlink.at/housing

You can also ask your settlement counsellor for help. To find a settlement agency near you, visit settlement.org/findhelp Shelters – Shelters provide short-term emergency housing for people who are homeless or in crisis. To find a shelter in your area, call 211.

## Post-secondary Student Housing

Universities and colleges provide housing for their students for an additional cost. On-campus housing often includes meals. Contact the housing department of the university or college you plan to attend for more information. Student residences are sometimes available to non-students in the summer.

- You may be asked to sign a lease a legal contract to rent for a set period of time, usually a year.
- You may be asked to pay your last month's rent before you move in.
- You may be asked to pay a security deposit. This should be returned to you when you move out, if there is no damage.
- You will usually be asked pay your rent on the first day of ever month.
- Your utilities, such as heat and electricity, may be included in your rent or you may have to pay for them separately.

- To be approved for a home loan you must have good credit. Speak to your bank about how to establish a credit history.
- When you make an offer on a house, it should be conditional on passing the home inspection. If a licensed home inspector finds that repairs are needed, you can cancel or change your offer.
